The Centers for Medicare & Medicaid Services (CMS) posted the final rule *Emergency Preparedness Requirements* to establish emergency preparedness consistency, increase patient safety during emergencies and establish a coordinated response to community disasters. Regulations must be implemented by Nov. 15, 2017.
