### CMS/Econometrica survey on HEN/HEN 2.0 Project Evaluation

We have been contacted by the PfP HEN 2.0 evaluation contractor asking for all our hospitals support in the independent impact evaluation of the Pfp 2.0. The evaluation is being conducted to:

1. Assess the impact the program had on reducing hospital-acquired conditions by 40% and readmissions by 20% from 2010-2015
2. Identify changes in hospital safety practice that occurred as a result of program participation.

Your CEO should have received an online survey on May 24th that needs to be filled out. **Please let your CEO know this is a real survey and vital to the continuation of HIIN project.**
